Historical/Biographical Notes

Members of the Stone family emigrated from Great Britain in 1635, and initially settled in Watertown. Family members soon migrated throughout Middlesex County, with Gregory Stone first residing in the northwestern part of Cambridge in an area that would become part of Lincoln in 1754. Other Stone family members acquired land in Rutland and Worcester County, and were prominent there. The Fiske family was also a very early family in Middlesex County. Nathan Fiske was settled in Watertown prior to the 1690s. Other family members settled in areas now Lincoln, Lexington, and Concord. The two families were often engaged in business enterprises, and intermarriage between the two families occurred in the 1700s. There is a suggestion from the records that a relationship between the two families existed in Great Britain prior to emigration.

Scope and Content

The collection comprises deeds, wills, and other legal documents relating to Stone and Fiske families from mid 17th century to mid 19th century. Financial records and correspondence of the two families is also included. Part of the collection relates to the Stone family in Rutland, 1718-1844. Also included is genealogical information on both the Stone and Fiske families, and miscellaneous records, including a legal controversy over a land purchase by Samuel Stone and others from Herbert Pelham of Great Britain.
