### **Historical/Biographical Notes**

A petition to the Governor and General Court in 1746 from the inhabitants of the easterly part of Concord, the westerly part of Lexington, and the northerly part of Weston requested to be set off from their respective towns in order to have a more convenient location for worship. A precinct was established, which gave the inhabitants authority to build a meeting house and hire a minister, the Second Precinct of Concord, Lexington, and Weston. A subsequent petition led to the incorporation of the Town of Lincoln in 1754, encompassing approximately the area formerly the Second Precinct. Evolution of Town government over 250 years has increased the number and kind of municipal services provided by Towns in Massachusetts. For over a century the people of Lincoln have acted to preserve open space, control development, and to preserve farmland. The Town has successfully developed an environmental awareness among its citizens, resulting in large tracts of open space and conservation land, municipally controlled farmland, and preservation of its water resources.

### **Scope and Content**

The collection comprises minutes of the Conservation Commission, Hanscom Field Advisory Commission, and other municipal committees relating to environmental aspects of Lincoln, 1982-2000; documentation relating to local, state, and national parks within Lincoln, 1927-1972; recreation, bicycle paths, etc., 1963-1973; materials relating to open space preservation and land use in Lincoln, 1929-2001; water resources and waste management in Lincoln, 1898-1984; materials relating to land use and environmental, including noise control, at Hanscom Field, 1968-2006; and other miscellaneous records relating to Lincoln's environment, 1930-1981. The collection comprises about 4 linear feet.
